



## TIME FOR A CHANGE

The italicized words you are about to read represent my report to the Board at our March meeting.

*I have been thinking long and hard about MWS- -where it is and where it is going. I think we would all agree with where it is today- -something of which to be very proud. During our last Board meeting I talked about the idea of a name change for this society. After some discussion, it was agreed that we shelve the idea for a future meeting. Well, guess what? The future is now! What I am about to share with you are my convictions regarding this future. What I hope to accomplish today is to set the wheels of change in motion. Everything has a beginning, so let it begin.*

*Our organization has grown to become a reputable watercolor society. In our early days, that was a pretty respectable goal. Today, I feel we are laboring under the umbrella of the implied regionalism provided by our name. I know that those who came before us worked hard to build, and live up to, a name that was given to this society, a name that has served us well. But now I feel we are faced with the irony of the need to break free from the restrictive nature of that very name- -Midwest. It is my opinion that it has become an anchor, not a sail.*

*Everyone here knows that today we are a national society. Yet, we continue to struggle with an image that falls short of that fact. Our own*

*museum search committee has told us that they have to explain our national scope to museums in order to help sell our product. When you have to do that, you can be sure, something is lost in the process. However, I find myself doing the same thing whenever I am talking to someone who wants to know more about us. I always feel compelled to sneak in the fact that we are national. If we were truly content with the implied nature of our name, would we work so hard to educate otherwise? I believe the reason we do so is quite simple. We have to! It is all about prestige and we are obviously looking for more of it.*



### Message from the **President**

*So why do we persist in advertising Midwest? Why continue calling it something we are not? I think the time has come for us to stand up and get the recognition we deserve. We will never get different results if we continue to do things the same way. And we are never going to really get that recognition unless we make a change. I believe that change must begin with our name. As I see it, the choices are simple. We can continue to allow our name to assert an area of origin or we can work to create a new name, one that declares the extent of our reach! We are big. I think it is time we help people become more aware of that fact. We need a name that says we are national!*

*Now, there will be those who will call it sacrilegious that we would even*

*consider this. I say, "So be it". At one time, I was one of them. I imagine there were those who thought the same thing in 1967 when the 47 year old California Watercolor Society decided to change its name to the California National Watercolor Society and again, in 1975, when it finally was voted to become the National Watercolor Society. We all know where that decision has taken them.*

*No one has a monopoly on success. I would like to see this organization succeed in the next 25 years like it never has before, and I see changing our name as the most direct route to that level of success. Our exhibitions are second to none! Our prospectus says national, our website says national, our exhibition catalog proclaims national, yet our name always holds dominion in distinctive bold letters, continuing to contradict. Change is needed and there is never a better time than the present.*

*When your name says you are big, people take notice. It says you are the standard by which all others are judged, and that is worth something. Everyone takes notice of the big boys, the artists do, the museums do, the press does, the public does, and, most importantly, the **award donors**. It is as simple as that. Of this, I am convinced!*

*I think we stand with an opportunity at our doorstep. It will require a bold and decisive leap on our part, but you cannot cross a chasm with small steps. If we want to be big,*

Plans are well underway for our 27th Annual Transparent Watercolor Exhibit at the West Bend Art Museum in West Bend, Wisconsin. The field of entries totaled 928! Carl von Marr was born in Milwaukee but received his art training in Munich. He earned quite an artistic reputation evidenced by the fact that leaders of three European Kingdoms knighted him.

For those of you who have never traveled to the Milwaukee/West Bend area of Wisconsin and are able to do so this summer, I strongly urge you to set aside half a day for a stop in Milwaukee to experience the magnificent Santiago Calatrava designed Quadracci Pavilion at the Milwaukee Art Museum. The schedule of festivities for our day of celebrating watercolor is as follows:

1-3pm Gallery Walk by John Salminen, AWS, MMWS

3-4:30pm Reception Hosted by the West Bend Art Museum

5:30pm Cash Bar and 6pm Awards Dinner at The Bog Restaurant

We will once again have a Silent Auction of paintings from prominent signature members. There will also be a drawing for those "in demand Kurecki Centerpieces" which was such a huge success last year. Enclosed in the newsletter is a dinner reservation form.

*I look forward to greeting you in West Bend.*

*then we have to start thinking big. If we want more attention and respect, if we really want to be measured against the best, then I believe it is time for us to seize the opportunity and grow. I think, after 26 years, the time is right for us to slip into bigger shoes, ones that fit us. And so it begins.*

The Board of Directors has consulted with our corporation attorney regarding the name change issue. He recommends that we change the corporate name by amending the Articles of Incorporation on file with the Secretary of State in Minnesota. Both the Articles of Incorporation and the bylaws of MWS are silent on the procedure to amend the Articles of Incorporation. The Not-for-profit Corporation Act of Minnesota requires that if members have a vote in corporate matters and if neither the articles nor bylaws specify the procedure for amending the articles, then the action must be approved by a majority vote of the members at a meeting at which a quorum is present in person or in writing.

The statutes authorize corporations to process the vote on amending bylaws by a written ballot similar to the process for electing directors of the corporation. The Board of Directors has carefully considered the name change issues as well as many suggested names. We agree that it is not feasible to conduct an actual meeting of the members since they live all over the United States and Canada. We feel strongly that the will of the full membership should be consulted and allowed to

determine the decision in this matter.

The Board Members had a list of ten alternative corporate names. Three names emerged for closer consideration.

Our corporation counsel investigated the three names and determined that one name: "The Transparent Watercolor Society of America (TWSA)" would be the most likely to be protected under the Federal Trademark laws and least likely to cause problems with other existing organizations with similar names. Therefore the Board of Directors recommends to the members of MWS that the preferred name be approved and that the Articles of Amendment be approved and filed with the Secretary of State to change the name of the corporation.

As President of the Midwest Watercolor Society, I hereby make a motion in writing that the voting members of MWS approve the amendment changing the name of the corporation to The Transparent Watercolor Society of America.

Attached to this newsletter, which is being sent to every current member, is a double-sided ballot. On one side, you are asked to vote for three names to serve as Directors on the Board. On the other side of the form is a written ballot for you to cast your vote regarding the name change. We ask that all members sign and return the form. We need at least 2% of the members to constitute a quorum and a majority of the persons who sign the consent form must approve the recommendation of the Board of Directors in order for this proposal to pass.

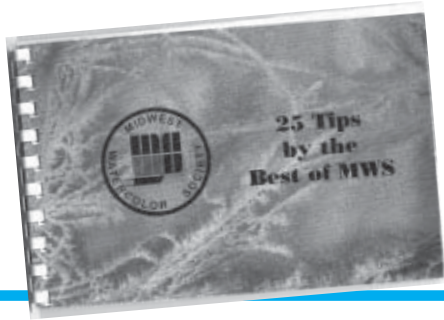

passed away on February 22, 2003, at the Villa Franciscan Nursing Home in Joliet, Ill. She was a life member of MWS and participated in many workshops during the 1990s.

**Dolores S. Rogers, MWS,** of Grand Island, New York, passed away in August of 2002. She very much enjoyed her membership in the Midwest Watercolor Society, especially recognition as a Signature Member

A longtime member, Randy Penner died on December 24. Other old timers will remember that both Randy and Lu were stalwart workers for the fledgeling MWS. Randy was a director on the first board.

His career started with commercial work and included a long stint as a staff artist for the Brown and Bigelow Calendar Company in the days when very large and prestigious illustrations were lavishly reproduced. In later years, and up to his death, Randy was still accepting free lance commissions from major corporations, mostly in the Twin Cities area. Another of his favorite affiliations was the American Society of Aviation Artists. He worked somewhat more loosely than other artist members.

A few years ago Randy authored a book titled, “A Harvest of Memories”, published by Reiman Publications. He illustrated the book with many full color paintings showing what it was like to grow up on a midwestern farm. Among these accomplishments by which we measure an artist, Randy was also proud of winning a major award in the MWS.
